Dear Dr. Law:

Thank you for your letter of June 9, 2015, conveying the teach-out agreement with Clearwater Christian College (CCC), which closed, effective June 1, 2015. Under the terms of the agreement:

- St. Petersburg College (St. Petersburg) will waive admission application fees for CCC students applying under this agreement.
- Students enrolled under this agreement will be required to meet St. Petersburg's program length requirement.
- St. Petersburg will offer only those courses for which it is already approved.
- CCC students enrolling under the agreement will be required to meet St. Petersburg's requirements for admittance into a particular degree program, including requirements for completion of required college preparatory work and completion of prerequisites, as well as all other graduation requirements.
- St. Petersburg will endeavor to accept the maximum credit earned by students, including credits earned at Clearwater Christian College and credits based on CCC's evaluation of applicable credit.
- Students applying under the agreement may apply in either the fall 2015 or spring 2016 term. Students who apply and are enrolled at another institution under that institution's teach-out agreement with Clearwater Christian College shall not be eligible to later apply to St. Petersburg College under this agreement.
- Students applying under the agreement will pay the current tuition and fees, and be subject to residency requirements for the purpose of assessing in-state and out-of-state tuition rates in accordance with institutional policy and state statutory provisions.
- St. Petersburg will permanently house the records of CCC students who officially enroll at St. Petersburg College. The records will arrive within ten (10) days of each student finalizing payments for tuition and fees with the St. Petersburg College Business Office.
- Obligations under this teach-out agreement terminate when all Clearwater Christian College students accepted under the agreement have graduated from St. Petersburg College, have failed to be continuously enrolled at the College, or after four (4) years, whichever comes first.
