Priority Deadlines

SPC's FAFSA Priority Deadline for Financial Aid PackagingFeb. 1
Admission to programs are aligned to students' first term (or session) at SPC and do not observe specific deadlines.

Tuition Due Dates

Universal Due Date for Full Term, Weekend College and First 8 Week Session.. April 19
If your tuition is not received or if you have not been awarded financial aid by this date, the classes you have registered for will be removed from your schedule. You can re-register for classes on a space-available basis.

Financial Aid Awarded Date for FAS Due Date Extension.....April 19
You can still apply for financial aid after this date; however, you will need to make arrangements for tuition payments while your file is processed.

Residency documentation for tuition purposes submission date May 22

Due Date for Second 8 Week May 26

Due Date for Express Session..... June 9

FAS Due Date Extension..... June 29

This extension is for students who are awarded a financial aid package by April 19. If your financial aid award does not cover the entire balance, you must pay your balance by this date. Students with an extended due date will not be dropped for non-payment by this date. The student may continue in the class, but will be billed for the amount owed. Future registration and official transcripts will not be available until the balance is paid in full.

Online enrollment begins March 27

0% down payment with 3 monthly payments and \$35 enrollment fee April 18

50% down payment with 1 monthly payment and \$40 enrollment fee..... May 19

Last date to increase the payment plan agreement balance May 19

Last date to decrease or terminate payment plan agreement balance June 26

Book Line of Credit

If you will have a remaining balance after tuition and fees are paid, you may use up to \$800 toward books and supplies.

Email	All email notifications are sent to your SPC student email <i>Students may forward their SPC student email to a personal email.</i>
Awarding	Financial aid awarding occurs DAILY, email notifications are sent DAILY
Verification	14 working days from the receipt date of all required documentation <i>Once complete, the verification item(s) will be removed from your MySPC To Do List.</i>
SAP Appeals	15 working days from the receipt date of all required documentation, email notifications are sent DAILY <i>Once a decision is made, the SAP item will be removed from your MySPC To Do List. To check the current SAP status, login to MySPC, select "Financial Aid Status," select the aid year and look in the box in the top right-hand corner.</i>

Students will be notified by email if, during peak processing times, the benchmarks above have been revised.
